Feasibility study on the establishment of a Greenstone Support Organisation for Africa (GSOA)

Purpose of study

The purpose of this survey is to elucidate the technical problems faced by African institutions and information professionals in creating digital libraries, and to conduct a feasibility study on the establishment of a Greenstone Support Organization for Africa (GSOA), which can help to resolve these problems.

Digital libraries can assist in the creation of local content and promote availability and preservation of content, as well as supporting capacity building in civil society. The open source Greenstone software suite for creating digital libraries (www.greenstone.org/) can play an important role in advancing human development in Africa and contributing to the dissemination of national and international information in civil society and by institutions in the fields of education, science and culture.

As the proposed GSOA is intended to provide continent-wide support, the study will take into account the needs of the Amharic, Arabic, English, French and Portuguese language regions, identify key challenges to the establishment and successful functioning of a GSOA and provide concrete recommendations for addressing these challenges.
